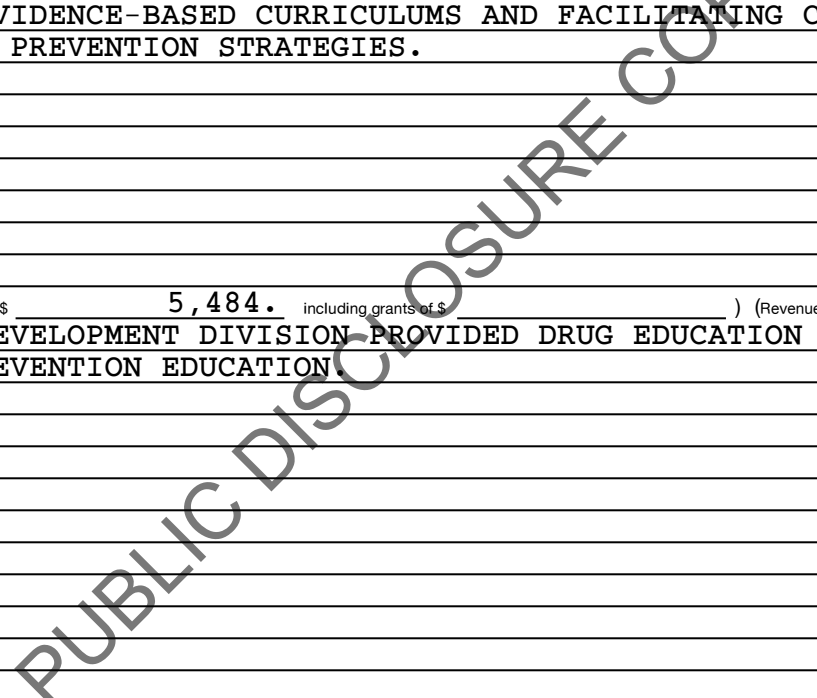

VICE PRESIDENTS COMPENSATION- FOR THE VICE PRESIDENTS OF THE ORGANIZATION, THE SAME FORMAL REVIEW OF COMPENSATION SCALES OF COMPARABLE NON-PROFIT ORGANIZATIONS IS CONDUCTED BY THE BOARD AND THEY THEN OFFER THEIR RECOMMENDATIONS TO THE CEO.
